### 4.0 Minor Council Chair Report

R. Hupka

- Report was circulated prior to meeting
- R. Hupka referred everyone to page 16 of the 2013 AGM Information Package.

#### 7.0 New Business

### 7.1 Hockey Canada AGM Report

### R. Hupka

- There was a notice of motion brought forth to Hockey Canada in August 2012 by Hockey BC with respect to Affiliation Regulation E. 35 a. This notice of motion was brought forward at the Hockey Canada Semi Annual Meeting in November in Montreal and was carried.
  - The rational is to standardize the maximum number of games an affiliated player can participate in. This change would bring all affiliation into line with the guidelines currently in place for Minor to Junior and Junior to Junior affiliation under the Canadian Development Model regulations. This procedure has effectively served as a barrier to "permanent affiliations" and this adjustment would eliminate confusion caused by having separate affiliation guidelines for different categories of hockey.
  - o The new Regulation will read as follows:
    - E.35(a) A player of a team of a lower division or category of the same club, or of an affiliated team, or a specially affiliated player, may affiliate to a team or teams of higher Divisions and categories at any time, to a maximum of ten (10) games. However, if the player's registered team completes its regular season and playoffs before the player's affiliated team or teams, the player may thereafter affiliate an unlimited number of times. For goaltender exceptions see Regulations B. 42, E. 36 (b).
  - It was noted that Hockey Alberta Minor Regulation 8.7 will now be amended to fall in line with Hockey Canada.
  - Question and discussion period on clarifying peoples understanding of the regulation change.
- R. Hupka highlighted the main items discussed at the national Minor Council Meeting in May in Prince Edward Island.

### 7.2 Hockey Alberta Officials Report

#### D. Shaw

- D. Shaw highlighted that there has been a noticeable increase in Match Penalties on Officials and they encountered a lot of issues during provincial playdowns.
- D. Shaw also noted that body checking in Peewee will be an issue to address. All of the instructors will be informed on how to properly educate the officials throughout this season's clinics. Atom referees do work in Peewee as well, so that should be an easy transition.
- D. Shaw touched on the officiating systems. The main officiating systems are 2-man and 3-man. There is also modified 3-man and the 4-man systems (used in the WHL). These two other systems require additional training.
  - If leagues are requesting the modified 3-man or 4-man systems, they need to submit the request in writing to their local Zone Representative who will then take it to the provincial Referee Council and it will be decided if there is enough manpower to deal with the request.
- Level 1 and new Level 2 officials will be taking a new online three hour course. Instructors
  will also be taking this course to be prepared when the clinics start at the beginning of the
  year. There will be a one day clinic process for all officials across the province.
- D. Shaw clarified that Hockey Alberta has no specific rule for mouth guards, but some leagues do. As there is no Provincial or National rule, Officials will not be calling any infractions with regard to mouth guards, it must be self-policed.
